Minister launches boat and school program

Gunggandji Rangers celebrated the launch of their new boat - 'Mulmulbarra' - earlier this month with Federal Minister for Indigenous Affairs Senator Nigel Scullion doing the honours.

Gunggandji Rangers deputy chair Daniel Noble said he was grateful for the opportunities Senator Scullion and the Department of Prime Minister and Cabinet (PMC) had provided for the group through funding the new vessel.

"It's certainly going to be a useful tool for our rangers, to ensure that the monitoring of our lands and our Sea Country will be conducted," he said.

"It's going to give those guys a

perfect opportunity to showcase what they've learnt."

Senator Scullion was clearly impressed as he inspected the boat after telling a crowd of more than 100 students and supporters that it was education - the subject of his second launch of the day - that would help drive the boat.

"It's really hard to look after Country if you don't have a car," he said.

"And it's almost impossible to assist in the looking after of your Sea Country, if you don't have a boat.

"Rangers will be travelling around in this boat, and they'll be helping monitor species, like dugong and turtle, to ensure that there are enough there.

"As soon as you start talking about measuring, monitoring and science, we need smart young men and women, like you."

Mayors' delegation on the road to Canberra

Yarrabah Mayor Ross Andrews is part of a second north Queensland delegation of Mayors on the road to Canberra this week, to push regional issues on behalf of their constituents.

The 12-person group was expected to meet with more than 30 ministers, senators and representatives from both sides of government during their trip.

"We have been granted access to some of the government's most senior ministers, as well as key shadow ministers, to discuss issues that are important to our region," Cairns Mayor Cr Bob Manning said.

He said discussions would take

in road planning and investment, water and energy security, management of the Great Barrier Reef and other environmentally sensitive tourist draw cards, digital connectivity, support for Indigenous communities, and the availability of financial assistance grants, among other topics.

"I'm proud to be standing alongside my fellow mayors on behalf of the

FNQ community," he said.

Cr Andrews will travel with Mayors from the Cassowary Coast, Douglas, Cook, Carpentaria, Croydon, Etheridge and Tablelands councils, and the CEO of Hope Vale Aboriginal Shire.

Last month five other north Queensland Mayors, including Palm Island Mayor Alf Lacey, made a similar trip to advocate for the region.

"Because an education is what allows you to become a scientist, and an education is going to be required for someone to have the qualifications to drive this vessel," Senator Scullion said.

"You've got to have to have an education to be able to understand about the biology of these wonderful animals, that you can see in some of these symbols, whether it is the sea eagle, or the turtle, or the dugong, or the fish.

"There are plenty of these jobs that are really exciting jobs but you need to be really well educated, and you need to study very hard at school."

Senator Scullion said the target of his second launch that day was the Remote School Attendance Strategy, also funded by PMC, where people in the community were employed to help get kids to school.

"We'll be employing up to nine people whose job it will be to get out of bed everyday and to work with families who are having some difficulties getting their children to school," he said.

"It's really tough, if you've missed school for three or four months, your parents might be away visiting someone or they might be away for medical reasons.

"When you come back, you're a bit behind, feel a bit shamed - so how do we break that?

"Yarrabah is a place of great ideas, so can I ask you all as a community to support these School Attendance Officers. It's members of the community who can, if you see kids down at the shops on a school day, out of uniform and looking well, just go and say, 'you're supposed to be in school'."

While he was in Yarrabah the Senator also met with Traditional Owners and the Yarrabah Leaders' Forum.

Gurriny Yealamucka staff, police, Council and community members have given Yarrabah paramedic Claine Underwood a big send-off into his new position as Queensland Ambulance Service Field Officer, based in Cooktown.

Yarrabah Mayor Ross Andrews said Mr Underwood would be missed.

“Claine has been a great role model for our young people here in Yarrabah,” Cr Andrews said.

“He will definitely be missed, but we wish him all the best in his new role.”

Mr Underwood said his new job was quite different to his current role in operational patient care.

“A field’s officer’s role is to go out and do community engagement and deliver any kind of first aid training or injury prevention programs,” he said.

“The role was developed to enhance people’s capabilities to manage emergencies in some of the remote areas around Hopevale, Wujal Wujal, Cooktown and Laura.”

We have data to support the argument
that children who live in houses that
have regular loud parties OR in close
proximity to these houses can have lower
attendance, higher behaviour referrals and
lower academic achievement.

High volume sound could easily effect
kids hearing, but of far more concern
would be the sleep disturbance to
everyone around and the negative
messages around the all night parties.

It is important our Paramedics
are able to rest and sleep
when they can without
unnecessary disturbances
from loud music or noise

“On one hand we say we want local people to be in those positions but when they do live here they can’t get the sleep they need to be effective in what they do,” Cr Andrews said.

Paramedic Richard Murgha said he and his team were on-call and needed all the rest they could get.

“It is so important our Paramedics are able to be rested and fully functional to perform the lifesaving duties that are required of them,” he said.

“It is a risk to our Paramedic and patients if they are working under fatigue because when people are fatigued they can make mistakes.

“We need them to be able to perform their duties to their fullest and provide the residents of Yarrabah timely and quality emergency care.”

Gurriny Yealamucka Health Services Dr Kingsley Pearson said not only could high volumes affect children’s hearing, but sleep disturbance was also an issue.

“My concern is that some of our patients with chronic diseases say lack of sleep is causing an extra layer

of stress and distress on an already difficult health journey,” he said.

Yarrabah Police OIC Erin Shawcross said they had responded to a number of incidents resulting from noisy parties.

“People travelling to and from the noisy parties have been involved in serious traffic crashes and other persons have become victims of assault and domestic violence,” he said.

“Restricted alcohol and illicit drugs have been identified at several noisy parties.

“Tenants hosting noisy parties could be prosecuted for a number of offences including ‘organising an out of control event’ and ‘permitting the use of the residence for drug use to occur’”

Yarrabah State School Principal Jason Evert said sleep, or the lack of it, had potentially huge impacts on our children’s life

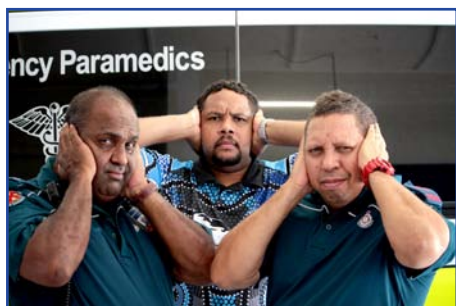
chances and future successes.

“As a parent, one of the most valuable things you can do to support your child’s education and success at school is ensuring they get a good night’s sleep, every night,” he said.

“Tiredness is a key contributing factor in many avoidable incidents we manage at school on a daily basis.

“When children come to school tired they are less resilient, have a shorter attention span, get frustrated easily and have a decreased ability to access their working memory, which is crucial to be able to learn at school.

“The children of Yarrabah are the future of Yarrabah and anything we can do to support them now will improve their chances of a happy and healthy future.”
