\$3m to get circular economy rolling



Mayor Mislam Sam (pictured with Local MP Scott Stewart) said the new modern waste and recycling facility supported Council's integrated focus on caring for land and sea country and the growth of a circular economy.

"With support from Palaszczuk Government, council has completed a major metal recycling project on island and we have placed twenty new metal bins around the Island with waste management, sustainability and caring for country messages on them," he said.

"Those messages were designed by the local school kids, and we are seeing an additional 2000 litres of waste removed from public spaces each week."

CEO Michael Bissell said it was a "wonderful" addition to the community's critical infrastructure.

"[The new facility] will be built adjacent to our new Palm Island

Circular Economy Centre that incorporates our Container Deposit Site, Men's Shed and Green Shed," he said. "This will enable community members to significantly increase their reuse and recycling efforts and ensure we maintain our pristine environment on Palm Island.

"Council's waste management objectives include all waste leaving the Island, zero discharge to land and waters and innovative waste management solutions."

Mr Stewart said the funding would deliver important environmental outcomes for the Palm Island community.

"This includes the removal of more than 500 tonnes of scrap metal from the island in the past 18 months, along with the supply of new rubbish bins and funding for a riparian zone restoration project," he said.

"The Government has also provided funding to council for a concrete

The Palaszczuk Government has committed \$3 million over three years to establish a circular economy centre and a waste recycling facility on Palm Island.

The funding will go towards:

- a new Waste and Recycling Facility.
- a Palm Island Circular **Economy Centre**
- community facilities including a Green Shed, Men's Shed and other programs, and
- preliminary site work and removal of legacy wastes

crusher and pulveriser, which has resulted in the recycling of 17,000 tonnes of concrete for use as road base, saving council up to \$1.5 million in costs for road repairs and construction.

"A container refund scheme is already operational on Palm Island, and I know locals and visitors to the island have commented on the difference the funding has made to the island.

"Effective recycling and better waste management is essential for our environment, and a circular economy on Palm Island is important to the community - that's why the Government is providing this vital funding assistance to Council."

- Under the direction and supervision of the Women's Case Manager, the Women's Case Coordinator will lead a small team on Palm Island, consisting of the Coordinator and Support Worker.
- The team will be an integral part of Criminal Justice System, and will offer an integrated court assessment, referral, and support service. The position will assist participants by connecting them with treatment and support services to address housing, employment, drug and alcohol, health, and other social needs.
- This position will be responsible for the case management
 of women with complex needs, including the provision
 of interventions to address issues related to offending
 behaviour. Women's social needs, particularly those of
 women in contact with the justice system, are often related
 to experiences of gender-based violence, specifically
 domestic and family violence and sexual violence.
- This role requires the development of strong linkages with the community services support sector on Palm Island.

3. Manager - Women's Case (Townsville)

- As the Manager Women's Case will have overall management of both the Townsville and Palm Island teams. The Townsville team will include this position and a Women's Support Worker; the Palm Island team will include a Coordinator and a Women's Support Worker.
- The position will be an integral part of Criminal Justice System, and will offer an integrated court assessment, referral, and support service. You will assist participants by connecting them with treatment and support services
