## Take care with roadworks!!!



Council urges caution around washed-out roads  
**Palm Island Aboriginal Council is urging residents to take particular care on our roads over the next few weeks, as water and flood damage is assessed and repaired as quickly as possible – weather-permitting, of course.**

Mayor Alf Lacey has also warned parents and children in particular to stay away from creeks, all of which are running fast, or can do so without warning if it rains upstream.

"We're calling on all community members to keep an eye on that as much as possible," he said.

With roadworks likely to take some time to complete, PIAC CEO Barry Moyle said particular care should be taken on the Airport and Beach Roads (*pictured above and below*), which were only half open due to land slips and water damage.

"People need to take it very easy out there, and to be aware that we haven't yet had a chance to check out some areas because they're still underwater," he said.

Mr Lacey said in the meantime the Council was working in conjunction with emergency services to do what they could to ensure the safety of all residents.

"We've been having some bad weather and our roads are not really good, they need attention and Council is working on some of those issues at the moment," he said.

"We'd like to thank the community for adhering to emergency service matters,

particularly over the past week or so with the prediction of a cyclone, where people have come on board and heeded the warnings.”

A spokesperson for Main Roads and Local Government Minister Warren Pitt told the *Palm Island Voice* that at this stage the extent of damage caused to roads by flooding and continuous heavy rain was “not known”.

“The repair bill is currently unknown and will be determined once all flood waters have receded and more detailed inspections of roads and bridges can be carried out,” the spokesperson said.

“Main Roads would like to thank communities for their ongoing patience as we work to restore safe access to north Queensland’s roads.”

Mr Moyle confirmed preliminary inspections and assessments by the Council’s own consulting engineers would start this week.

He said Road Tek engineers were also expected on the Island this week as part of their ongoing and scheduled programs.

“We were declared as eligible for Natural Disaster Relief as of last Friday, so that means once we’ve reached \$117,000, we can then claim everything we spend over that from the State Government,” he said.

“So the resources will be there to fix it, it’s just a matter of how quickly.”

Mayor Lacey said it was important for residents to be aware of weather reports, especially potential cyclones.

“I think the community has responded very well so far,” he said.

“We’ve managed to see through this rough weather, no doubt there’s more to come, and I think it’s important that we continue to keep a watch for ourselves.”

## Lane way bridge not safe for vehicles

The old main road bridge beside the day care centre is badly eroded underneath and is not safe for vehicles, PIAC says.

Steel bollards were recently put in place to stop cars from crossing but someone has removed them, potentially putting lives at risk.

The bollards have since been replaced with rocks – Council and the works department is asking residents to please not interfere with these.

The culvert drain near Beach Road has also eroded to the point that half the road is now blocked off – residents should obey the traffic signs there and are also asked not move or remove these, for their own and others’ safety.

The council is working to fix these problems as soon as possible, please be patient.

## Roads to benefit from Council networking

**Palm Island Council looks set to join an alliance which should help to improve local roads and help strengthen ties with other Shires across the region.**

Council CEO Barry Moyle said a regional CEO’s meeting held last Friday in Townsville was held at the same time as a regional Mayors meeting between Townsville, Burdekin and Hinchinbrook Shires.

“These are meetings that

have just begun and Palm is included,” he said.

“So the CEOs were talking about some regional planning issues and how Palm Island fits into that planning.

“We also spoke about the ‘Roads Alliance’ which is a collection of all the local governments in the area.

“That looks at how they can save money by working together, using resources and tendering for road works on a

bigger scale.”

He said at this stage PIAC was not part of the Alliance.

“I was able to raise that and the CEOs were keen to have Palm Island involved,” he said.

“So it will be included on the agenda at the next Mayor’s meeting, that Palm Island be added to the group.

“It was good to get involved so people know there is a council out here and that we are part of the region.”

# New tenancy rules to be in place by July 1

**Tenancy arrangements, including rent, on Palm Island are set to change on July 1 this year in line with all communities across Queensland.**

Housing Minister Robert Swarten said the changes would ensure Indigenous communities had access to the same standards of housing assistance as the rest of Queensland's social housing tenants.

He also said the Department of Housing would be introducing its rent policy to all Indigenous communities, including Palm Island.

"The department is working closely with the Palm Island Council to communicate the changes to tenants and provide training and support to Council housing officers," he said.

"To further support this change, the department will also be providing tenancy management services to the Palm Island Council."

Mr Swarten said the department had met with the Council a number of times and was now awaiting Council sign-off on an agency appointment which would allow the department to assume responsibility for the tenancy management of the properties.

"I acknowledge that the transition of tenancy management and the application of the 25% household income rental policy will present some challenges," he said.

"However, departmental staff will work closely with the Council and the community to ensure a smooth transition takes place."

Mayor Alf Lacey said the Council was obliged to conform with the changes.

"There's certain conditions and new housing arrangements across all communities in Queensland," he said.

"Come 1 July 2009 rents will be increased to 25% of all household income, which is in line with the Queensland system.

"Currently we don't operate under that system but it will be similar to when you're in a housing commission home.

"The Council did ask the government for some more time so the community could talk more about it, they haven't given us that though,

and they will implement it by July this year.

"Council is disappointed in that but we don't have any say over it because at the end of the day they fund housing in all communities so the ball is in their court.

"So all we can do is try to ensure that we are geared up to these changes, it's a big step and there will be issues around it but I hope we can work together on ensuring we get as much information out to you as we can."

Mr Swarten also said the Queensland Government would provide \$5 million for additional housing on Palm Island to respond to overcrowding.

"This will provide a mix of housing types including housing for small families and single people," he said.

"Plans are now under way, with construction likely to commence around the middle of this year."

"The Queensland Government is committed to continuing to work closely with Indigenous communities and Councils to improve housing conditions and services for Queensland's Indigenous people."

Mr Lacey said housing was a priority for PIAC.

"We will see new houses going up this year, which is important because housing is always a priority for us," he said.

"What the Council has done is concentrate a bit more on young people so you'll see a lot of flats and units going up over the next 12 months to house young people and young families.

"Traditionally we've put up three-four bedroom homes around the town to accommodate bigger families but that's created more of a problem because we end up in an overcrowding situation.


"This time we thought we'd try and concentrate more on young people so that's what's going to happen with this \$5 million housing program for 2009."

# Nominations close on Friday for new rep body talks in Canberra

**Nominations close this Friday for Aboriginal and Torres Strait Islanders who want to positively contribute to discussions about a new national Indigenous representative body by attending a national workshop in Adelaide from 11-13 March.**

Aboriginal and Torres Strait Islander Social Justice Commissioner Tom Calma (*pictured*) said attendance at the workshop would be decided through a selection process.

"Only individuals who have completed a nomination form addressing the selection criteria will be considered for attendance," he said.



Selection criteria includes that applicants must:

- be an Aboriginal and/or Torres Strait Islander
- be nominated by an Indigenous community organisation or self-nominated with two written references supporting the nomination
- have demonstrated leadership capacity and ability to take part in high level discussions on strategic issues
- be able to communicate and interact effectively with a diverse range of people
- have demonstrated capacity to represent views and interests
- be able to make a positive and considered contribution to the discussions and deliberations on the establishment of the new national Indigenous representative body, and
- be available to attend and participate in the program and events for the whole workshop.

Commissioner Calma said the national workshop would be limited to approximately 100 people and would focus on reviewing submissions and the outcomes of the federal government's consultations to date on the establishment of a new representative body.

"The national workshop will not be endorsing a final model for a national representative body nor will it be deciding membership of a national representative body," he said.

In December 2008, the Australian Government requested the Aboriginal and Torres Strait Islander Social Justice Commissioner at the Australian Human Rights Commission to convene a Steering Committee to develop a preferred model for a national Indigenous representative body.

The Steering Committee is required to:

- convene an Indigenous Peoples Workshop in March 2009, with a possible second workshop in June 2009;
- develop a preferred model for a new national Indigenous representative body for presentation to the Australian Government in July 2009;
- make recommendations regarding the establishment of an interim body from July 2009 which would operate until the finalised body takes effect; and,
- ensure strong community support for such a representative model.

**With all that weather we've been experiencing, flights in and out of Palm Island have been operating according to conditions, says Dreamtime Logistics Operations Manager Marisa Kingston.**

Mrs Kingston said passenger safety was their number one priority.

"We're not interested in putting people's safety in jeopardy just to earn a dollar," she said.

"The weather is a safety issue, that's why we haven't been able to put the planes up in the air, although we are able to fulfil flights to Palm when we can legally fly."

She said erratic weather, poor visibility and low cloud cover had been keeping their planes on the ground because it was illegal to fly to or from the Island at less than 800ft.

She said people could still make their bookings and keep in touch with what was happening via phone, fax or email, with their website due to be operational soon (see details below).

"If the landline isn't answering people are welcome to send texts to the mobile if they need to," she said.

"It's been very hard not working out of an office in Townsville, that's for sure."

Flights prices vary from \$70 one-way for residents and up to \$160 return for non-residents.

The company is presently carrying out a survey, copies of which are available from the Palm Island airport, 4K1G in Townsville or via email.

Secondly I wanted to update the community on the housing agreement with the federal government and for Palm.

For more about that you can read the story on page three of this issue of the *Palm Island Voice*.

The \$40 million home ownership program with the federal government is also under discussion at the moment, we've got a meeting coming up shortly.

We'll keep you informed on the arrangements that the previous Council signed off on.

Certainly we're putting other issues onto the table at these meetings to ensure not only that we are getting new homes for home ownership on the community but there also needs to be more infrastructure.

It's no good to see our community living in nice homes with poor infrastructure, so we're continuing to lobby for that.

I attended the Community Cabinet meeting last month in Townsville with the CEO and lobbied quite a few Ministers for more infrastructure and various projects for Palm.

Those meetings went very well, we've managed to sit face to face with Ministers, and that's something I'll continue to do as Mayor, to lobby and make sure we're not being forgotten in terms of the basics.

It's important that we continue to do that.

Roads and the creeks being up is also of particular concern to Council at the moment (see page one).

Council would like to assure our residents that outside of the damage caused by our recent weather, our usual road upgrades will continue to happen in terms of the TIDS program.

Because of the wet, as we all know, there's been more damage done and Council has made that a priority at the moment, and engineers should be on the Island sometime

this week to assess that situation.

The other thing the Council is doing is negotiating a retail precinct, there's a feasibility study that's being done at the moment by Indigenous Business Australia who are working with the Council.

Hopefully we'll have a supermarket and about ten shops for locals to be a part of, so it's really important that we ensure the feasibility study continues to happen.

We've also been saying to the government that the retail store needs to come back into community control, so hopefully this new retail precinct for Palm will encompass all that.

As a part of the precinct there'll also be an accommodation attachment as well, so that's some exciting news for us.

We understand now that there's also new changes to CDEP.

At this point in time we don't know what it means in terms of effect for Palm Island but no doubt Coolgaree CDEP will inform everyone of what those changes mean.

Also the Indigenous Coordination Centre has made a commitment to come in and give the community an update on what's happening and what will happen over the next couple of years.

It's really important to be aware of that because the majority of our people are employed by CDEP and it's an important program that delivers a lot of services and infrastructure for our community here on Palm.

In other things, we also need to be mindful of the dredging happening at the wharf at the moment, but once that's finished we'll be seeing Sunferries come in at any hour of the day instead of on tidal times.

I've also attended meetings with the Bwgcolman Tribal Council, they're local

people in the community so if you need more information on that contact Tom Geia, Alf Clay, Edward Walsh or Stephen Boyd, who are now working on resurrecting that organisation.

They have a charter of things they want to do and see for Palm and I've given a commitment from Council that we will work with them to get extra benefits for Palm.

I think people should be aware that body is there to represent the Bwngcolman people's needs and wants in terms of land and other issues.

These are things that the Shire Council continue to pursue so we're supporting this new local group which will in turn support us, that's very important and a very good idea that group is now establishing itself to help us all get things done for Palm.

We're continuing to negotiate with the Department of Natural Resources around land matters for Palm.

They're proposing an ILUA so Council is continuing those discussions with the Manbarra people and there are representatives of the Bwngcolman people also sitting at those meetings.

Council will continue to work with this to get some positive outcomes for the community and our Shire.

The Council has also made it clear that we want to see some major projects go ahead for 2009.

There are major works that need to happen because at the end of the day that means the community gets better services and better access to those services.

The new government service offices and the

new Court building are also online and it looks like April will be the official opening date.

These are a few of the things that have been happening over the past few months or so.

Over the next 12 months it's certain that the economic crisis will have its effect on us and that's going to create some challenges because that will impact on us.

We're not separated from that in terms of the Council budget and things like that, so it's important to understand that what's being said in the media at the moment is very serious for us and we need to be mindful of that.

The kids are back at school now as well, whether they're attending locally or going to board schools we'd like to wish them all the best for their studies over the next 12 months and hope they do well in their new grades as well.

I'd also like to welcome our new teachers who have taken up the challenge to come to our lovely Shire and work in our classrooms to ensure the education of our kids.

For this new year I also want to encourage people to participate in our community delegation Council meetings, the dates of which will be advertised in the Palm Island Voice.





