Housing summit demands results over 'argy bargy'

Prime Minister Malcolm Turnbull and his Government's decision to cease the National Partnership Agreement on Remote Indigenous Housing (NPARIH) was the focus of a meeting between Queensland Mayors, local government leaders and housing experts in Cairns earlier this month.

Testing the waters

The meeting was attended by mayors and representatives from Palm Island, Torres Strait Island Regional Council, Wujal Wujal, Napranum, Yarrabah, Pormpuraaw, Northern Peninsula Area Regional Council, Hopevale, Woorabinda, Mapoon, Kowanyama, Torres Shire and Cook Shire, and hosted by Cairns Regional Council.

They have vowed to increase pressure to stop the government from walking away from the issue.

A joint-statement from the Aboriginal and Torres Strait Islander Mayors said anything less than the existing program, due to finish at the end of this financial year, would reverse gains made in Closing the Gap targets in health, justice, education and community well-being.

"The meeting also resolved to push to end the exclusion of the communities of Yarrabah, Cherbourg and Torres Shire from national indigenous housing program funding," the statement said.

Wujal Wujal Mayor Desmond Tayley said the meeting served as a follow-up to a similar meeting in Canberra last month.

"The State Government were committing beyond the 30 June but the Federal Government is playing the argy bargy," he said.

March was a big month for rain in our community as creeks became rivers and roads became creeks, as these pics show.


And this month is shaping up to be more of the same with some long-range forecasters predicting a soggy end to match the soggy start to April this year.

"They [State Government] want the Federal Government to negotiate with them, but they haven't done it," Wujal Wujal Mayor Desmond Tayley said (from page 1).

"The Federal Government hasn't shifted, that funding will finish at the end of June and that's it, then it's a State Government responsibility."

Palm Island Mayor Alf Lacey also used the words "argy bargy".

"I think it's really important that we don't want to buy into the argy bargy between State and Federal," he said.

"We're only interested in seeing houses being delivered on the ground for our people.

"Another round of investment from state and the federal governments is really important for our community when we look at the numbers of housing needed in our community.

"There is a lot of to-ing and fro-ing and a lot of politics in between but at the end of the day our role on the ground, and particularly as a local government who deliver all of these services, is about ensuring our people are getting the same access as any other Australians and that's what this is about."

Yarrabah Mayor Ross Andrews said they didn't want to compete with other communities.

"We want to encourage the Government to continue funding housing stock for all our communities," he said.

"All the social determinants are affected by this issue."

If this government were serious about closing the gap, it certainly would not be cutting \$245 million of funding over two years to a program in Queensland that is a huge success.

In Queensland alone, the National Partnership Agreement on Remote Housing includes the delivery of approximately 1,150 homes, approximately 1,500 refurbishments, as well as maintenance for almost 4,300 houses over a 10-year period.

This partnership has created a large number of local jobs, particularly in Queensland, for Aboriginal and Torres Strait Islander people.

...over the last 10 years, the total number of employment opportunities funded through the NPARH has been 2,640.

That's concreter's, plumbers, carpenters, electricians, roofers, labourers, painters, tilers and cabinet-makers.

Today, the National Partnership Agreement on Remote Housing supports the ongoing employment of over 850 Aboriginal and Torres Strait Islander employees, apprentices and trainees, and seven of those apprentices live in my electorate of Herbert, on Palm Island.

These cuts will result in these seven apprentices losing their jobs, as well as thousands of jobs in regional Queensland, not to mention the impact on small business.

...In my electorate of Herbert on Palm Island, there are people living in self-constructed accommodation with no electricity, no plumbing and no running water.

- ... This funding is vital for Palm Island.
- ... More homes are desperately needed.

The Remote Housing Review identifies the need for 1,100 additional homes in remote Queensland communities over the next 10 years.

...Time and time again our First Nations people have called on the Turnbull Government to give them the respect and recognition they deserve.

And time and time again, their calls are ignored. These cuts are simply wrong.

I will fight against these cuts and I will continue to fight until the Turnbull Government fund the National Partnership on Remote Housing!

Boxing tournament postponed

AN invasion of boxers and officials from as far away as Kingscliffe, just over the border in New South Wales Rockhampton, Mareeba and Cairns. as well as a little closer to home from Home Hill and Townsville were due to converge on Palm Island on Saturday for our first boxing tournament in three years but the event has been postponed due to the weather. Palm Island Voice will keep you posted, so watch this space for a new date!

It is expected Palm Island's best men's and women's rugby league teams will take the chance to play on a national stage when the 2018 Arthur Beetson Foundation (ABF) Deadly Choices Murri Knockout carnival is held in Townsville this year.

Palm Island Mayor Alf Lacey has already been approached to be a guest speaker at the official opening.

In what is bombshell news, Palm Island Voice can report that
Townsville's Bindal Sharks was invited in March to partner with the ABF to present the carnival at the Townsville Sports Reserve where at least 24 men's teams will battle it out from October 5 to 7.

Bindal Sharks supremo Jenny Pryor has run North Queensland's biggest Allblacks carnival in Townsville for the past 31 years.

"My management team is over the moon we have been offered the opportunity to have the carnival here," she said.

Since the ABF carnival started in 2011 no Palm Island team has been able to afford to compete at the prestigious event.

Costs for airfares, accommodation and other outlays were too much

for many potentials north of Rockhampton to consider it.

The Townsville Murri Knockout will be held instead of Bindal Sharks normal carnival.

Teams and players from around the State will battle it out and already one from Western Australia has asked for a nomination form.

ABF hold the rights to the Murri Carnival from the QRL.

The QRL, Deadly Choices and the ABF have been looking for an opportunity to bring the carnival to North Queensland and how to deal with logistics of that.

The carnival is QRL sanctioned and all competing players must have health checks before games.

ABF officials will discuss matters with the QRL and obtain their blessing to the relocation of the carnival for 2018 which is expected to be a formality.
